

Micro & Small Enterprises Cluster Development (MSE CDP)

About-

MSE CDP stands for the Micro and Small Enterprises Cluster Development Programme. It is designed to enhance the productivity, competitiveness, and capacity building of Micro and Small Enterprises (MSEs) and their collectives. The program includes components such as setting up and modernizing Mini Technology Centres to support MSEs effectively. The MSE-CDP program aims to develop infrastructure for micro and small enterprises by providing support for establishing common facilities, testing labs, design centers, and more.

Benefits-

Common Facility Centres (CFCs): The GoI grant will be restricted to 70% of the cost of project from Rs.5.00 crores to Rs.10 crores and 60% of the cost of project from Rs.10.00 crore to Rs.30.00 crore. In case of NE & Hill States Territories, Aspirational Districts, GoI grant will be 80% of the cost of project from Rs.5.00 crore to Rs.10.00 crore and 70% of the cost of project from Rs.10.00 crore to Rs.30.00 crore. The project of the CFC with project cost more than Rs.30.00 crore can be considered but the GoI assistance would be calculated by taking into account the maximum eligible project cost of Rs.30.00 crore

Infrastructure Development: The GoI grant will be restricted to 60% of the cost of Project from Rs.5 crores to Rs.15crores for setting up of new Industrial Estate/Flatbed factory complex. In case of NE and Hill States, Island territories. Aspirational Districts, GoI grant will be 70% of the cost of the project from Rs.5.00 crore to Rs.15.00 crore for setting up of new Industrial Estate/Flatbed Factory Complex and 60% of the project cost from Rs.5.00 crore and Rs.10.00 crore for up-gradation of existing Industrial estate/Flatbed Factory Complex. The Project for ID with project cost more than Rs.10.00 crore/Rs.15.00 crore can also be considered but the GoI assistance would be calculated by taking into account the maximum eligible project cost of Rs.10.00 crore/15.00 crore

Application Process-

- Enter Your User Id and Password. Apply - New Guidelines of MSE-CDP. After sign in take your own time to fill up all the requested fields of application form.
- Finalize application and once finalized no change can be done. Take the printout of the application sign and send application along with desired documents if any.
- The state government will forward the same to the concerned MSME-DI for their recommendation/verification and further, submission to the office of DC-MSME, within 30 days failing which the applications, will be deleted from the system automatically.
- The applicant is also provided with an option to enter his comments online regarding routine of his completed application, so that monitoring can be done on the flow of the applications
